Transfer Agreement

East Stroudsburg University and Northampton Community College

East Stroudsburg University (ESU) and Northampton Community College (NCC) have established the following Transfer Agreement to facilitate the transfer of students from the Associate in Applied Science (AAS) Degree in Criminal Justice at NCC to the Bachelor of Science (BS) in Criminal Justice program at ESU.

Terms of Agreement: An NCC student who has earned the AAS Degree in Criminal Justice shall be guaranteed admission to the BS Degree in Criminal Justice at ESU provided the student meets the following terms of this agreement:

- Cumulative GPA: Graduate from NCC with a minimum grade point average (GPA) of 2.00.
- Major GPA: Graduate from NCC with a minimum Major GPA of 2.00.
- Transfer Credit: ESU will accept a total of 64 credits from NCC with an earned grade of 'C' or better as outlined in the Criminal Justice Transfer Agreement Course Guide.
 - Please Note: Students with a conferred (AAS) degree in Criminal Justice from NCC may transfer credits in courses where the grade of 'C-' or 'D' is earned if the student has an overall GPA of 2.00 or higher.
- **College Transcript:** Submit an official final NCC transcript, indicating receipt of the AAS Degree in Criminal Justice directly to the ESU Office of Admission prior to matriculating to ESU.
- **Enrollment:** Enroll at ESU within one year of graduation from NCC. Not attend another institution of higher education between NCC graduation and enrollment at ESU.
- Applying: Submit an application, with application fee, for admission as a transfer student to ESU.
 Students are encouraged to apply well before the application deadline dates. (Please refer to the ESU Transfer Student website for the online application link, application deadline dates, additional resources, and ESU transfer counselor contacts: www.esu.edu/transfer.

NCC Criminal Justice (AAS) to ESU Criminal Justice (BS) Transfer Agreement Course Guide

Transfer Credits: Upon receiving an AAS in Criminal Justice, NCC students will be transferring a minimum of 64 credit hours into ESU. The following courses will transfer with a grade of "C" or better, and a 2.00 cumulative and major GPA. **Please Note:** Students with a conferred (AA) degree in Criminal Justice from NCC may transfer credits in courses where the grade of 'C-' or 'D' is earned if the student has an overall GPA of 2.00 or higher.
