# East Stroudsburg University of PA Academic Agreement Terminology

### **Contract:**

• An agreement between two or more competent parties, upon consideration, to do or abstain from doing some legal act.

### Internship:

- An opportunity to integrate career related experience into an undergraduate education by participating in planned, supervised work.
- Characteristics of internships:
  - o contributes to the student's personal and professional development through challenging work assignments
  - o is completed before the student graduates from the university although in some cases internships can be completed the summer between the student completing the undergraduate degree and before beginning a graduate degree program
  - o is planned and scheduled through consultation with the department or college so as to fit into the undergraduate experience
  - o involves a supervision component that is mentoring and educational
  - o includes career related experiences that complement what is learned in the classroom
  - o will have a reflection and evaluation process at the conclusion of the internship
  - o builds upon the relationship the department/college/university has with employers
  - o is most successful when the student, the department/college, and the employer all share responsibility in making it a valuable experience
- Meets needs of Individual students
- Faculty are typically not on-site supervising internship work\*

## Affiliation:

- Agreement between East Stroudsburg University and another entity for purposes of providing an educational opportunity for students generally in a supervisory situation such as a clinical experience, an internship program, or a student teaching assignment
- Such contracts can be with federal agencies (*i.e.* prisons or Veterans Administration Hospitals), other state entities, school districts or private companies/businesses
- The purpose of such agreements is to memorialize each party's rights and responsibilities in regards to this educational opportunity
- Course credits with established program guidelines
- Moderate faculty involvement\*

### Clinical

- Intense faculty involvement \*
- Direct hands-on care in a professional setting; typically with the faculty member doing the instruction in an external site

## Memorandum of Understanding

- Agreements between Universities within PASSHE or with another State agency
- An interagency agreement whose purpose is to enable all parties to facilitate the conduct of certain efforts of mutual interest.
- MOUs are not intended to, and do not, create any contractual rights or obligations with respect to the signatory agencies or any other parties.
- One of the defining characteristics of an MOU is that a dispute arising under the MOU is submitted to another agency party, such as the Office of General Counsel, the Office of the Chancellor, etc. for final resolution.

#### **Articulation**

- Formal process for awarding credit for education provided by another institution.
- Allowing you to take educational requirements as efficiently as possible.
- An agreement between two academic institutions regarding the administration of a joint degree or cooperative academic program. (PASSHE Handbook)
- Student pays tuition to the external institution, not to East Stroudsburg University.
