

- Budget, Finance and Planning- Gregory Boyce will fill the unrestricted senator position
- Research- IRB Representative needed, Head of Office of Sponsored Projects and Research will be added. Kelly Varcoe will fill the open senator position.
- Nominations and Elections- Unrestricted senator spots will be filled by Brandon Synder, Holly Wells and Marguerite Carver.
- Academic Affairs- Open Health Sciences position will be filled by Keith Vanic.
- b. No objection to committee members, committees approved
  - Additional members added to committees as needed
- c. Proposal: Delay the add/drop and withdrawal window by 2 days for shortened sessions (i.e. winter).
  - Proposal brought forward due to high DFW rates in shortened sessions. Belief that the session is too short and that students don't know their standing in the class (grade) prior to add/drop ending.
  - Originally asked to apply this concept to Summer session as well but the impact on financial aid would not make this possible.
  - Moved by Rob Cohen to the floor, second by Jill Boyle.
  - Open for discussion- Leo in Office of Financial Aid will need to be involved in the discussion to see the impact on aid. Potential impact on the refund policy should also be examined.
  - Proposal from Andi McClanahan to move this proposal to Academic Affairs Committee for further review.
  - Second from Brook Langan to move to Academic Affairs Committee.
  - No objections to making the referral, approved by general consent.
- d. Proposal: Efficient funding for professional tutors to meet the needs of the students.
  - Proposed by Christopher Brooks, Johan Eliason, Jan Hoffman, Susan Dillmuth-Miller, Keith Vanic and Darla Drummond
  - Christopher Brooks will speak to the proposal- Professional tutoring program disbanded in 2010 and 2011 due to being unsustainable. Proposal to identify ways to make it sustainable and bring it back to benefit students.
  - Seconded by Holly Wells
  - Presentation by Kelly McKenzie and Matthew Simmons on current tutoring program
  - President Long will confer with Provost Ball about the possibility.

### 10) Open Discussion –

- a. Student Issues: Marijuana Policy Enforcement; Fighting
  - Addressed as a safety concern in senate last year. New concerns about marijuana smoking in dorms and questions about new policies put in place.

- Curtis Dugar to address the concerns and questions- Any student who smokes (of any kind) in residence halls will be held accountable and referred to student conduct for adjudication. Added structure to the housing agreement to include expectations and penalties. University invested in sensitive smoke detectors for the suites in the stairwell. Staff on duty can see when students are smoking and get a reading of what they are smoking. This information can be used to gather data about who is violating the policy. If students are caught tampering with the smoke detector they will be held accountable and given tampering violations concerning the public health issue.
- Lauren Stemler to address the Conduct related issues- student code of conduct outlines the process and how the University upholds student due process.

  Student conduct website has the updated student code of conduct.
- Chief Elick to address law enforcement component- education and prevention at the forefront instead of arrest. Combined program with Monroe County for minor infractions.
